THEME PRESENTATION:

Throughout the years, the Common Agricultural Policy (CAP) has been subject to numerous changes and adaptations to the producers' and consumers' needs, to the environmental problems, under the pressure of climate changes, for a sustainable and inclusive growth. The debates on post-2020 CAP reform gained consistency when the European Commission published its vision on the future of agriculture and food in the European Union. The public consultation in the first half of the year 2017 on the theme of CAP modernization and simplification confirmed that the current CAP instruments can address the existing challenges only to a certain extent, the environmental and climate challenges in particular, as domains on which most farmers and other stakeholders consider that CAP should focus more.

In its vision on agriculture and food, the European Commission advocates a smarter, more modern and sustainable Common Agricultural Policy, which should provide support to farmers for fair incomes, to finance investments aimed to improve the positioning of farms along the chains, ensure risk management, environmental protection and climate actions,

at the same time contributing to strengthening the socio-economic structure of rural areas and attracting young farmers to farming activities.

Economic growth and job creation in the rural areas remain CAP priorities, as the rural areas are facing structural problems such as lack of attractive employment opportunities, lack of investments in basic services and young people's low interest in living in the rural area. The rural workforce should have better access to vocational training, to skills development programmes, to quality education and connectivity. The new rural value chains such as clean energy, emerging bioeconomy and circular economy can create jobs and new opportunities for rural areas.

At the same time, the renewal of farmer generations should be a priority for the future policy, and a better implementation presupposes a better correlation between the national and the EU actions. Romania is one of the EU member states that is mostly affected by the young people's exodus from the rural area; therefore new concrete support measures are needed, for the organization of producer associations inclusively, with the massive simplification of procedures regarding the access to EU and national funds, as well as with a wide range of projects dedicated to young people in particular.

CAP modernization has also in view introducing new technologies and wide-scale innovation (the EU research programme Horizon Europe for research and innovation projects in the agri-food sector, rural development and bioeconomy), which will also contribute to the renewal of generations in agriculture and rural area. An adequate framework must be created for risk management, in order to better face the production, price and income risks, as well as for remediating the structural deficiencies.

For Romania, agriculture is an important strategic sector, yet the growth of the sector to reach the potential of its resources is still an ongoing objective. The social and economic effects obtained as a result of CAP implementation in Romania have been the object of numerous research studies, and the context of CAP modernization and simplification for the new programming period provides the framework for new opportunities for study and research in the field.

OBJECTIVES:

The aim of this scientific event is to bring together researchers, academics, experts and decision-makers in agriculture, forestry, agricultural economics and rural development as well as from other related areas, to debate theoretical, methodological and practical issues concerning the agri-food sector evolution and development opportunities, in the context provided by CAP modernization and simplification for the programming period 2021-2027. The participants are invited to present their main concerns and the results of their recent research work in the investigated fields. This scientific event will also represent a good opportunity for creating new partnerships and identifying new areas of cooperation in scientific research.
